

# Share Agreement

Covering the share of the Horse/Pony (kept at Badgers Farm, note 14) known as ‘**PONY NAME**’

(The “**Horse/Pony**”)

1. The Share Agreement will start on **DATE** and continue until terminated by either party
2. The **SHARER** may terminate this agreement by giving one month’s notice. The **OWNER** may terminate or suspend this agreement at any time without giving notice.
3. It is understood by the **SHARER** that the **OWNER** remains the registered owner of the **Horse/Pony**.
4. The **OWNER** is responsible for all farrier, veterinary and livery costs.
5. The **SHARER** may ride the **Horse/Pony** up to 1 day(s) per week for no more than **1.5 hours** per day as agreed in advance with the **OWNER**.

- The **SHARER** may ride the **Horse/Pony** for no more than 1 hour per day if in 'the school'. With 45 mins to include a 10 minute warm up and a 15 minute cool down, after the session, with a total of 1 hour's riding.
6. During these times the **SHARER** is responsible for the **Horse/Pony** and shall also carry out the following duties:- Grooming (including picking out the feet before and after being ridden), Tack cleaning which includes **rinsing the bit** after use and Turn Out (if required).
  7. It is understood by the **SHARER** that they will not allow any other person to ride the **Horse/Pony** without the **OWNER's** prior permission.
  8. The **Horse/Pony** may be used by the **SHARER** for lessons, schooling, and hacking. Any other use (such as jumping or taking to a show "off-yard") requires prior permission from the **OWNER**.
  9. If the **SHARER** uses the **Horse/Pony** within riding lessons or competitions the **SHARER** is responsible for the payment of any lesson fees or competition entry fees.
  10. The **SHARER** is required to take out Rider Insurance Cover for all their activities with the **Horse/Pony** and a copy of current and any renewal insurance certificate must be provided to the **OWNER**.
  11. In addition the following special requirements and precautions apply to the **Horse/Pony** - **NONE**
  12. If for any reason the **SHARER** is unable to attend to the **Horse/Pony** on the agreed days the **OWNER** must be informed in advance so the **OWNER** can make alternative arrangements for the **Horse/Pony**.
  13. The **SHARER** shall donate **£25** Per week, equaling **£108** per calendar month payable on the 1<sup>st</sup> of each month in advance to the **OWNER**, by bank transfer, upon receipt of advice from the HBL RDA Treasurer. The **OWNER** reserves the right, by way of giving one month's notice, to request an increase in the donation should it be deemed necessary.
  14. The **Horse/Pony** is to be kept at Badgers Farm, High Barn Road, Effingham, SURREY, KT24 5PP (the "YARD") and the **SHARER** must abide by the Rules of the **YARD** at all times.
  15. The **SHARER** will promptly inform the **OWNER** or **YARD** staff if the **SHARER** notices that the **Horse/Pony** has incurred any illness or injury.
  16. The following pieces of equipment are supplied by the **OWNER** and it is agreed by the **SHARER** that they are in good working order and free from any defects: Bridle/Reins/Bit/Saddle/Stirrups & Leathers/Numnah (+pad if required)/Head Collar/Lead rope, Grooming Kit.
  17. Any damage to tack or equipment noticed by the **SHARER** or **OWNER** during the period of this agreement must be notified to the other party promptly.
  18. The **SHARER** will agree to take all reasonable care to prevent the **Horse/Pony** being injured or suffering an accident while being handled or ridden.
  19. The **SHARER** acknowledges that riding is a hazardous sport, undertaken entirely at the handler's/rider's risk. That all animal behavior is unpredictable and that neither the **OWNER** nor representatives will be liable for any accident or injury that may occur to any person(s), property or animal during the period of the share.
  20. This Agreement shall be governed by the Law of England.

## Addendum

Only 1 rider may ride the pony per session unless otherwise agreed on the share agreement.

No swapping AM or PM sessions outside of the days allocated on the share agreement, unless previously agreed with Fiona.

The poo picking in your ponies field falls under the agreement and a minimum of 15-20 minutes should be allocated each time you ride to complete this activity. It is understood that 50% of the time is spent riding and 50% spent, grooming, tacking up and untacking, cleaning tack, sweeping the tying up area, scooping the poop in the fields.

Whilst it does not happen very often, ponies do experience lameness from time to time. Where we will always try to arrange catch up days this will not always be possible. And it will not be considered that any days are owed in lieu. We cannot always arrange catch up days if you go on holiday or cannot make your share day. Where possible and if we have pony availability we will.

All Ponies and Horses will have 1-2 weeks off work at an agreed time of the year, by the Trustees, which may change year on year. This is fixed and comes under the Share Agreement.

Our ponies are very precious and work very hard in their day jobs with their RDA riders. We ask you to look after them and love them as much as we do and treat them and all their accessories as if they were your own.
